## Election Summary Report Colusa County

Colusa Basin Drainage District Landowner Election Summary for: All Mail Ballot Election Official Results August 29, 2023

Pursuant to Elections Code 10525(a)(b) the Secretary of the Landowner District delivers a list of voters qualified under the principal act of the District to vote in that county at the next landowner district election. The list will include the manner in which the votes are to be distributed. There were 5,325 unique landowners for 8,255 eligible parcels. Each eligible voter shall have one vote for each one-thousandth of one (1) percent attributable to the land of the eligible voter out of the total benefit received by all lands within the district. Fractions shall be rounded to the nearest onethousandth with each voter entitled to at least one vote.

\*All elections shall be on a basis of one vote per acre or fraction thereof, as shown on the county assessment rolls owned by the eligible voter.
