Update on Earthquake Monitoring Station Project

From Jonah Merritt, Operations Manager:

It's been an incredibly wet year and we have been unable to get into sites to construct them. Many areas are drying up, especially in the valley, with will allow us to get out to construct and install new stations.

The Clark Valley site is on our list to construct in our next mobilization. I need to talk to our contractor on scheduling, but I am hoping that we will be out there toward the middle of May to build the site. I presume the roads to the site have dried out, or will be in a few weeks without significant rainfall. The roads there will need to be very dry since we'll need to get a truckload of gravel in there for weed abatement.

Hi Ben,

I wanted to ensure you received a solid response to your question about the audit finding from the June 30, 2020 audit.

Although you referred to the audit adjustment as Unaccounted funds, that is not the case.

The audit adjustment recognized \$6,506 of income in the 2019-2020 fiscal year and an associated Accounts Receivable. It was a case of the income originally being recorded in the incorrect year. The deposit of \$6,506.33 was recorded on 2/18/21 as the 'RPA Stabilization Fund Report ACWA-JPIA'. The auditors were reclassifying that check from being recorded as income in the 20-21 year to the 19-20 year. The original check, which was probably mailed in February 2020, was lost in the mail and the replacement wasn't received until February 2021. Because the check was originally issued in 2020, even though the District didn't receive it until 2021, the auditors wanted it reported in the 2019-2020 year.

I did not receive any more responses from Ms. Vanderwaal regarding the unresolved issues including the \$6506 in unaccounted funds and the Colusa County cash investment account but expected that these questions would be resolved at the scheduled August meeting at RD 108 office. These financials were approved at the September 1 Special Meeting and as I have mentioned there were several interested parties including myself who did not have any Notice of this Meeting and the quorum was reached by remote attendance as I mentioned in my previous email.

Thanks for the reply Merrilee,
I did not know about the two year rule.
I think the big issues are just doing the due diligence around balance sheet issues since you are taking over and it is probably best if you do a good due diligence review for a solid foundation going forward.
Maybe look at the Amended Note and make sure it matches the disclosure.
Break out all the capitalized costs for the project in case it needs to be written off due to a partial or full impairment
Finally – you probably should make sure that the accountants have verified all the assumptions made about the Colusa County Fund. Looks like they have extended duration in 2021 since it is really hard to get over an average life of 1 year if you keep 70% in short term instruments. Looks like they may have some interest rate risk in the portfolio to come up with the 2021 weighted average.
Also – it is probably best to describe the scope of activities for the CBBD beyond flood control.

Hi Ben,

I will try to answer your questions as I know right now. I saw the audited financials at the meeting on Thursday for the first time as well.

- 1. CBDD does a two-year audit. Because the accounts are held at Colusa County, we are allowed to just do an audit every other year that covers both years. So this audit was for the years ended June 30, 2020 and June 30, 2021. 2. The binding of the reports is done at the option of the auditor. The letter to the Board is a separate document from the audited financial statements and is circulated differently. 3. It is standard practice to date the representation letter as the same date as the auditor's report. 4. I am having to research the \$6,506 receivable. I will get back to you on it. 5.  - 1. Were the Audited Financial filed for 2020? Is this a comparison report between 2020 and 2021 or is intended to cover both Fiscal Years?
 - 2. Does it make sense to have two bound reports rather than having the report to the Board as the first part of the bound submission?
 - 3. Was the Representation Letter dated the same date as the Report? Not sure what is normal here.
 - 4. What was the \$6506 receivable that was understated?

5. What is going on with Page 4 of the Report – Schedule of Uncorrected Misstatements? No mention why this page is part of the Report.

Financial Statement Comments

- 1. Page 3 Maybe We have also issued our Report to the Board of Directors dated .. This will make a clear integration for review
- 2. Page 13 Should Jim or you be the contact By the way have you actually looked at the Note and Deed of Trust to make sure the amended terms are as represented? Just mentioning this since you are picking up the management responsibility and this is the material liability of the District so maybe it should be part of the transition due diligence
- 3. Page 21 you may want to broaden out the purpose beyond "flood control"
- 4. Page 23 Have you reviewed the Fund Investment statements. Looks like the county bought longer term debt during fiscal year 2021? Actually 54 bps loss market to market in the low interest rate environment of 2021 is kind of material.
- 5. Page 27 did the auditor actually do due diligence on this to back up this footnote?
- 6. Page 29 The capitalized planning expenses are included with Land
- 7. Page 32 Note 11 This assumes all \$ 5.5 million is real estate. Just the real estate should be included in costs.
- 8. There should be a footnote about the potential for writing off the capitalized project expenses. The Board has indicated that the Project may not proceed and there will be an material impairment in the FY 2022-2023 if that is the case.
- 9. Page 38 flood control purpose only again on top of Page

Can you let me know if 2020 Audited Financials were prepared.	Looks like there was an engagement letter in
July of 2021 but maybe nothing done?	

Also what was the unstated receivable for \$6506 for.

Otherwise just comments but I do think you need to break out the project costs and start the discussion about potential impairment.
