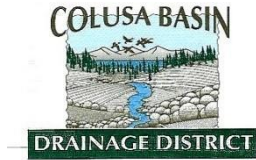

Goal is to bring more developed information to the Board for projects – one in each county – as well as landowner initiatives.

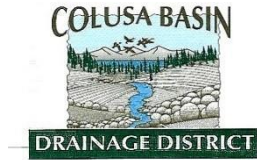
Consider CBDD's role as a facilitator by working with grantwriters or consultants to execute.
