RESOLUTION 2023-04

CONTINUED LEVY OF AN ANNUAL BENEFIT ASSESSMENT FOR DISTRICT EXPENSES ON LAND WITHIN THE COLUSA BASIN DRAINAGE DISTRICT PURSUANT TO THE COLUSA BASIN DRAINAGE DISTRICT ACT AND CALIFORNIA CONSTITUTION ARTICLE XIII D, SECTION 5

WHEREAS, the COLUSA BASIN DRAINAGE DISTRICT (“District”) is a special district created by the Colusa Basin Drainage District Act (“Act”) California Stats. 1987, Chapter 1399 as amended; and

WHEREAS, Sections 610 and 700 et seq. of the Act authorize the District to levy a benefit assessment to fund expenditures made, or expenditures estimated to be required during the following calendar or fiscal year, for any lawful purpose of the District, including, but not limited to district administration; engineering and other expenses in connection with the investigation and preparation of a resource management plan or plan for any work or project; acquisition or construction of any work or project; and operation and maintenance of any work or project; and

WHEREAS, on November 17, 1995, the landowners of the District approved the District’s Initial Plan, and by a majority vote authorized an annual assessment under the provisions of the Act (Cal. Const., art. XIII D, § 5(d)); and

WHEREAS, the voter-approved benefit assessment of an amount not to exceed ten cents (\$0.10) per acre as shown in the assessment roll with a minimum assessment not to exceed five dollars (\$5.00) per parcel for each separately assessed parcel has not changed since originally authorized in 1995; and

WHEREAS, Glenn, Colusa, and Yolo Counties have been authorized by the State Board of Equalization to collect any assessments levied by the District and are authorized by Government Code Section 29304 to impose a charge for such collection.

NOW, THEREFORE, BE IT RESOLVED that the COLUSA BASIN DRAINAGE DISTRICT hereby adopts the following order:

1. The previously voter approved benefit assessment of ten cents (\$0.10) per acre as shown on the assessment roll, with a minimum assessment of five dollars (\$5.00) per parcel for each separately assessed parcel on all land within the District, shall remain in place for the 2023-2024 fiscal year.
2. The District warrants and represents that the taxes, assessments, fees and/or charges imposed by the District and being requested to be collected by County comply with all requirements of state law, including but not limited to Articles XIIC and XIID of the California Constitution (Proposition 218).
3. Glenn, Colusa and Yolo Counties shall collect this assessment levied by the District utilizing the tax bills of the respective counties and there shall be added to each assessment a collection charge as established by the appropriate County pursuant to agreement between each County and the

District, as prescribed by Government Code 29304.
