

RESOLUTION NO. 2024-06

SETTING REGULAR DISTRICT MEETING TIME AND LOCATIONS

AS A BASIS AND PREMISE for this Resolution, the Board of Directors of Colusa Basin Drainage District (the "District") finds as follows:

1. The District is a special act district formed under the Colusa Basin Drainage District Act ("Act"), with territory in Glenn, Colusa, and Yolo Counties; and

2. Pursuant to Section 127-210 of the Act, the District should adopt and publish a resolution setting the meeting date, time, and location for its regular monthly meetings; and

3. Notwithstanding Section 127-210's provision for a regular monthly meeting, it has been the long-held custom of the District to convene meetings to conduct business on an every-other-month or quarterly basis; and

4. Also pursuant to Section 127-210, the District may conduct special meetings at any other time according to the provisions of the Ralph M. Brown Act (Government Code Sections 54950 and following); and

5. The Board of Directors wishes to establish regular meeting locations that provide for regular participation and access to all landowners within the District's boundaries.

NOW, THEREFORE, the Board of Directors does hereby RESOLVE and ORDER as follows:

1. The District's regular monthly meeting shall be held on the second Monday of every other month at 1:00 pm, noticed and conducted consistent with the requirements of the Brown Act.

2. Unless otherwise specified by the Board of Directors, the District will hold regular monthly meetings in the following months, convening at other times only as necessary to conduct District business:

August, October, December, February, April and June

3. In order to facilitate the full participation of all District landowners, the District's regular meetings shall be held on a rotating basis at the following locations, unless otherwise noticed:

- 5005 State Highway 20, Williams, CA (Westside Water District)
- 5513 CA-162, Willows, CA (Tehama Colusa Canal Authority)
- 122 Old Hwy 99W, Maxwell, CA (Sites Reservoir Office)

4. The District may, at the pleasure of the Board and on a temporary basis, convene a regular or special meeting at any other location conducive to the conduct of its business, provided that it complies with the Brown Act in its noticing and conduct of those meetings.
